Brief details of dispute/litigation	The Company has received a communication from the Directorate General of GST Intelligence (DGGI), Belagavi Zonal Unit, regarding alleged ineligible availment of Input Tax Credit (ITC) on services availed in connection with its Initial Public Offering (IPO) during FY 2021-22 to 2023-24 and 2024-25. The authority has indicated that such expenses relate to the issue of shares, which is considered a non-GST supply, and has advised payment of tax, interest, and penalty aggregating to ₹3,44,89,344 and ₹4,36,78,720 or submission of a representation by 27.08.2025. The Company is in the process of examining the matter and will take appropriate action in due course.

4.	Expected financial implications, if any, due to compensation, penalty etc.	The Company has received tax demand from the Authority as follows: - For FY 2021-22 to 2023-24 - ₹4,36,78,720 - For FY 2024-25 - ₹3,44,89,344
